at his home.

The 53-year-old man was flown to St. John's Mercy Hospital just hours after Vernon Barnett, 81, had been flown to Elvis Presley Trauma Center in Memphis, Tenn., for treatment after he, too, was severely burned trying to put out a grass fire at his Broseley home. Barnett died from his injuries on Sunday. His obituary appears on page 6A.

"I think the neighbors were burning trash, and it got into (the man's) yard," Shaffer said. "He was trying to stomp it out and caught himself on fire."

On Feb. 22, commission members voted unanimously to recommend denial of Devine's request. At the Poplar Bluff City Council meeting Monday night, no one made a motion to accept or reject the recommendation.

City Planner Dennis Avery said Devine was "not willing to meet all the stipulations.' She wanted to wash vehicles outside the building, but Avery had stipulated the washing must be done inside the building in wash bays so the wastewater would flow into the sanitary sewer system. The property is located in a C-1 neighborhood commercial district.

After a discussion by council members, Devine said, "Okay, you win. The cars will be washed on the inside. The clothes (in her resale shop) will be moved outside on racks."

According to Deputy Michael Tinker's report, Barnett had been severely burned.

must have trash Dumpster or receptacle and a new owner must apply for a new permit.

The appointment of Jeff Shawan to the Planning and Zoning Commission was approved. He was the only applicant to replace Melanie Thomas, who resigned due to working more hours.

An agreement with Missouri Highways and Transportation Commission regarding the Oak Grove Road project was moved to the March 15 session. The project involves upgrading Oak Grove Road to 'improve safety and increase the capacity for traffic by widening, regarding, adding curb and gutters and improving drainage appurtenances," according to the agreement.

The project will begin at North Westwood Boulevard and proceed west approximately 3,500 feet, which is a short distance west of Shelby Road. This new road will extend from Highway PP to Business 67 at Highway W. At the time of the Oak Grove Road construction, if funds permit, the improvements may be extended farther west,

Barnett, who was able to speak, told Tinker he had been burning brush.

"Barnett stated that he had turned around for a minute and that the fire had come up behind him and caught him on fire,' Tinker said. "Barnett stated that he tried to get his clothes off, but that the fire spread too quickly."

Two men on the same weekend having their clothes catch fire is "very unusual, but it can happen," explained Butler County Fire Chief Bob Fredwell.

Since people have been inside all winter, they want to get out and clean up their yards, Fredwell said. Many, he said, were burning the limbs from last year's ice storm over the weekend.

"I don't think people realize how dry it is; the ground is so wet underneath, but the top is freeze died," Fredwell said. "The nights we've had and the days of low humidity" in the 20-percent range makes the fire danger "definitely very high."

While the humidity has been higher this week, Fredwell said, tomorrow is supposed to clear off and be breezy.

"We'll be in the same boat," he said. " ... It's very, very dry" and people need to be "very, very careful."

The Poplar Bluff City Council decided Monday night to reject a recommendation from the Animal Control Advisory Board to reduce the number of pets allowed per household to four.

After three residents spoke and the council discussed the proposed amendments to the Animal Control Ordinance, Councilwoman Susan Williams made a motion to change the number of pets from four back to the current six.

Council members approved the amendment before adopting the entire Animal Control Ordinance. Both votes were 6-1.

"I voted no because it was too confusing," Councilman Harold Tinsley said after the meeting.

Councilman Robert Smith, City Manager Doug Bagby, Mayor Loyd Matthews and Williams said they had received several phone calls or comments from residents opposed to reducing the number of pets to four.

nesses in one building," Councilwoman Susan Williams said. Council members also were concerned about water flowing onto the bricks on Main Street and creating a traffic hazard.

Devine had previously agreed to abide by the other stipulations, which included limiting business hours to 8 a.m. to 8 p.m. Monday through Saturday, no sale of vehicles, no washing of motors or transmissions, no sales of fuels or oils, no repairs, no painting, a limit of 10 vehicles during business hours, a limit of three vehicles during non-business hours, no off-street parking,

Carolyn Bremermann said she has more than six animals, but they were grandfathered in when the number was set at six. She said they were dropped off at her house.

"I am not in agreement with the amendment (to reduce the number to four). I feel it is intrusive into a person's privacy," Bremermann said. "I think this should be thought through a little longer.'

Under the new ordinance, litters of dogs and cats are not included in the household limitation initially, but when they reach sufficient maturity, the owner or custodian shall be required to limit the number of animals to six.

"I also don't agree with the limitation of four pets," said Robin Powell.

Pit bulls will be phased out under the new regulations. Any pit bull/mix dogs within the city prior to enactment of the ordinance shall be exempt, but when it dies, it shall not be replaced with the same breed.

Current owners of pit bull/ mix dogs must have the dog microchipped and register the owner's information, photos but not past Bypass 67.

"We receive \$74,000 per year in surface transportation program funds. They have built up to little over \$400,000," City Manager Doug Bagby said. "This agreement allows us to access those funds, which will offset some of the cost of the \$2.2 million project."

Council members accepted a \$19,014 bid from Buffington Brothers Heating and Cooling of Poplar Bluff to replace a rooftop air-conditioning unit at Black River Coliseum. The other bid was \$20,500 from Precision Heat and Air, Inc. of Poplar Bluff.

of the dog and a complete description by April 1.

"The Animal Control Board has been working on this for two years. They have put a lot of thought and time into this ordinance," said Bagby, who added several other cities have already adopted similar ordinances for pit bulls.

Greg West said he would like for the council to add a requirement for pit buil owners to purchase a \$50,000 liability insurance policy for their dog.

"It is in our ordinance for any dog determined to be dangerous," Bagby said.

Another change is under the abusive treatment of animals. Any person convicted of abuse shall not be allowed to own an animal for not less than one year. Any guilty person found in possession of an animal within the one-year period shall be fined not less than \$500 with the years of not owning an animal reinstated with a new date.

A new section was added that prohibits the keeping of bees or hives within the city limits
